Rule (15) of Club Rules – CHILDREN

- a) All Junior Members at 31 May 1998 shall subject to paragraph (b) of this Rule cease to be Members of the Club.
- b) The unmarried children below twenty-one (21) years of age of Life, Honorary, Ordinary (Transferable), Ordinary (Non-Transferable), Associate (Non-Transferable), Social (Transferable), Social (Non-Transferable), Term, Subscribing Members and nominees of Corporate Members shall be entitled to use those facilities of the Club as such Members or Nominees are entitled to use subject to the Rules and Bye-Laws of the Club, provided they are registered with the Club, and provided monthly subscription are paid.
- c) The registration of the child at the request of the Member or Nominee may be subject to conditions as the Committee may determine from time to time. The registration of any such child may be cancelled at any time at the absolute discretion of the Committee.
- d) A Member who has registered his child shall be responsible for all debts incurred by the child.
- e) A child of any Member who is not registered with the Club and for whom subscriptions are not paid shall only make use of the Club's facilities as a guest and shall be subject to Rule 26.
- f) The Committee shall have the right to exclude any spouse or children of either a Member or Nominee of a Corporate Member from the premises of the Club and from the use of facilities of the Club indefinitely or for such period as the Committee may determine without assigning any reason whatsoever.
- g) No spouse or child shall have any right to be heard before the Committee. The Committee shall be entitled to take action against that Member or Nominee as if such conduct were the personal conduct of that Member or Nominee.
